

Punjab, Chandigarh, the required NOC is being issued by the Punjab Government on the following terms and conditions:-
 - a. That if in future on any complaint/inspection the fact comes to light that at the time of applying for NOC you had provided false information to the government or you will not abide by the instructions issued by Punjab Government from time to time and do not abide by the terms as mentioned in the affidavit then in that eventuality this no objection certificate can be withdrawn

- b. It will be compulsory for your school to teach English as a second standard and CBSE will make sure to conduct examination of Punjabi in these schools and it is hereby informed that for not doing so this no objection certificate can be withdrawn anytime.
- c. School Management will have to comply as it is with the notification issued by the Punjab Government under R.T.I Act, 2009 and rules of R.T.I Act, 2009 applicable in state of Punjab.
- d. After taking affiliation from CBSE New Delhi, School Management will be bound to pay to the Teaching Staff and Non-Teaching staff the salary and other allowances through account payee cheque as are payable to government employees. If not done so this no objection certificate can be withdrawn anytime.
- e. You yourself and your management will make sure that whenever the Education Officer of your district or any senior official of Education Department will sought any information then same will be provided to him and required coordination will also have to be provided. If not done so this no objection certificate can be withdrawn anytime.

forwarded to Government so that it can be known that school is complying with the instructions issued by Punjab Government.

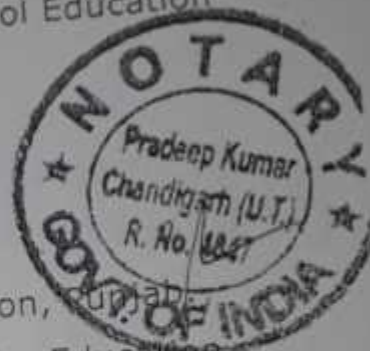
